Cumbria mines access

Dave Hollingham, Mountain Experience (07387588500, mtmexperience@aol.com) has invested a great deal of time and effort in organising mines inspections throughout Cumbria to enable group access.

Inspections have been completed for **Smallcleugh** (annual) and **Tyne Bottom** (bi-annual). These are category 3 and will require regular inspection. Also **Goldscope Mine** near Keswick has also been inspected. These have been funded by small groups of providers. If you are interested in gaining access to these reports or contributing to the next round of reports, please get in touch with Dave Holingham.

Inspections are due to go ahead on 10th June for a first round of venues in the Coniston area, notably **Hodge Close** and **Coppermines Valley** with sufficient funds pledged to fund a second day probably in the autumn which is expected to focus on the **Old Man of Coniston** and possibly the Tilberthwaite area.

The primary focus for these inspections is on venues that will fall into category 1 or 2 and should not require further inspection by a mines inspector unless there is a significant change reported by users or their technical expert. Use of these simple venues should be possible through local training and advice without the need to become a Mines Leader. It is hoped that some more extensive venues may be approved for use in future which may then lead to needing to be a qualified Mine Leader.

Those supporting this will become members of the Cumbrian Mine Inspection Report Scheme. A list of members will be maintained by Dave in the first instance. All paid up members will have access to the full range of reports funded by the scheme and a facebook page and email group will be established for members to provide and receive updates.

Invoices are being sent to the providers who have declared their intention to support this scheme. If further providers wish to support this in the future then any additional funds will be put towards extending the range of inspected venues. **This is open to any activity providers that would benefit**, so if you are interested in finding out more please contact Dave directly.

The Cumbria based <u>Land and Nature Skills Service</u> (LANSS) has recently been established with a website currently being developed and full launch due in September 2024. The idea is for LANSS to act as a hub, improving access to training and learning across the farming, forestry and environmental sectors. I am representing IOL on the stakeholder group and will be championing the broader outdoor learning sector.

The Outdoor Partnership Coastal Cumbria has now been running for 4 years. Its focus is to 'work with clubs, schools, individuals and specialists to increase opportunities for people in coastal cumbria to achieve their potential through outdoor activities, active participation, volunteering, training and education.' The project is lottery funded and engages a Stakeholder group who identify



local needs that TOP can help meet by sourcing funding and making connections between providers and communities.
